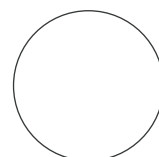

# Do I have to complete the confirmation of residence form?

If you want to continue to benefit from the preferential terms of the Duo Partner GA or Familia GA Travelcards, you must complete the enclosed confirmation of residence form and have it authenticated by the local authority. A charge will be made for this service. It varies from one residents' registration office to another. The local authority authentication must not be more than 30 days old. The documents needed for renewal are listed below.

## Duo Partner GA Travelcard

This travelcard is available to people who are living in the same household, regardless of gender or marital status. If one person holds a standard GA Travelcard, a second person can benefit from the preferential terms of the Duo Partner GA Travelcard. The following documentation is required:

## Familia GA Travelcard

Available to families living in the same household. If either parent holds a standard GA Travelcard, children can benefit from the preferential terms of the Familia GA Travelcard for children or Youth. If either parent holds a standard GA Travelcard and at least one child holds a Familia GA Travelcard for children or Youth, the other parent can benefit from the Familia Partner GA Travelcard. The following documentation is required:

The child does not live with the parent who holds a standard GA Travelcard (parents live apart)	<ul style="list-style-type: none"> <li>• Copy of family register of person(s) with a child or children or of the child's birth certificate</li> <li>• <b>Confirmation of residence for young persons aged 16 or over, including the parent who does not hold a standard GA Travelcard</b></li> </ul>	<b>Yes</b> (if the child is aged 16 or over)
